contact lists, flyers, leaflets, research papers, legislation, briefs, speaking notes, press releases, personal notes, buttons, stickers, petitions, reports, agendas, minutes, correspondence and notes. The collection was donated to the BC Labour Heritage Centre in 2018 as part of the 35-year retrospective project, Solidarity35.
